MONKS KIRBY PARISH COUNCIL

Minutes of the meeting held on 14th November 2019.

Meeting started 7.30pm.

Apologies: Cllr. Woolliscroft.

Declarations of Interest with regards to items on the agenda. Nil.

Public Participation Session with regards to items on the agenda (15 minutes). **Fishponds Community Park**

A resident of Brockhurst Lane attended. The resident has children with special needs and they visit the Fishponds Community Park weekly. For younger children or children with additional needs the playground is not suitable and has limited activities. The resident and several other residents with young children asked if there might be any way of expanding the park and put new things in that are more suitable for children with special needs?

The attendees suggested a sunken trampoline – as had been done in Nuneaton, funded by Georgie's gift. Could the School to be involved? Sewing and growing of flower meadow? The council explained that money used to add to playground is obtained through grants. An application could be made to the trustees of the Lady Mary Trust – educational & health items not provided by existing funds.

The residents mentioned Daffodil Sunday and whether it might be a good idea to have a stall for fundraising?

The Council confirmed they would welcome any thoughts about how to raise this money. Residents to plan out exactly what is needed.

Bridleway to Pailton from End of Bell Lane

The residents commented that this path is almost impassable with pushchairs and has become narrow over time and grown over. Would it be possible to make path wheelchair accessible?

The council confirmed that this path is in the Pailton parish.

WALC – Parish Mapping.

Cllr. Gillias attended WALC (Warwickshire and West Midlands Association of Local Councils) meeting last Saturday and discussed Parish Mapping. This is a computer-based programme which is updated every 6 weeks and gives updates of maps e.g. listed buildings, flood plains, designated areas of special interest. Useful for considering planning applications. Cost is approx. £50 per year – Cllr. Gillias is trying to get it rolled out to Parish Councils.

Ansty Park.

Developers of Ansty Park are working on the first warehouse which will be fully operational by October 2020. This will employ approx. 1,000 people.

Two further applications are expected to be put forward end of this month for two other buildings. One application is for Cadent gas, measuring 80,000 square feet with a 650-space car park. Mitigating measures are being put forward to try to direct traffic. Cadent will have a fleet of vehicles.
